In a major move to bolster its broadband infrastructure, AT&T announced on Wednesday, May 21, 2025, that it has agreed to acquire the Mass Markets fiber business of Lumen Technologies, CenturyLink's parent company, for \$5. The deal, which includes approximately 1 million fiber. The most recent North American Fiber Deployment Report by RVA LLC Market Research & Consulting (RVA) released in January 2025 presented more records for the progress of fiber across America. 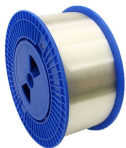
